



2. SAFETY REGULATIONS

IMPORTANT SAFEGUARDS

When using electrical appliances, basic safety precautions should always be followed to reduce the risk of fi re, electric shock, and/or injury to persons, including the following:

- Read all instructions and information in this instruction book and any other literature included in the carton referring to this product before operating or using this appliance.
- 2. Do not touch hot surfaces (i.e. steam wand). Use handles or knobs.
- To protect against fi re, electric shock, and personal inury, do not place cord, plugs, or appliance in water or other liquid.
- 4. This appliance must be kept out of the reach of children.
- 5. Unplug from outlet when not in use and before cleaning.
- 6. Allow to cool before putting on or taking off parts, and before cleaning the appliance.
- 7. The use of accessory attachments not recommended by the appliance manufacturer may result in fi re, electric shock, or personal injury.
- 8. Do not use outdoors.
- Do not let cord hang over edge of table or counter, or touch hot surfaces.
- 10.Do not place on or near a hot gas or electric burner, or in a heated oven.
- 11. This machine was designed to process normal household quantities only. Not suitable for continuous operation or commercial use.

- 12.Do not operate any appliance with a damaged cord or plug, if the appliance malfunctions, or has been damaged in any manner
 - Return appliance to an authorized service facility for examination, repair, or adjustment.
- 13.Do not use if the water tank is not filled.
- 14.Always use cold water. Warm water or other liquids could cause damage to the appliance.
- 15. When plugging in the machine, always turn appliance "OFF", attach power cord to the machine fi rst, then plug cord into wall outlet. To disconnect, always turn appliance "OFF", then remove plug from wall outlet.
- 16.Use extreme caution when using hot steam.
- 17.Do not use appliance for other than intended use.

SAVE THESE INSTRUCTIONS

SHORT CORD INSTRUCTION

A short power supply cord is provided to reduce the risk of tripping over or becoming entangled with a longer cord.

The cord should be accessible after installation of the machine in order to disconnect it at any moment if necessary.

Longer extension cords are available at retailers authorized to sell electrical accessories, and may be utilized if care is exercised in their use. If an extension cord is used:

- The marked electrical rating of the extension cord should be at least as great as the electrical rating of the appliance.
- If the appliance plug is grounded, the extension cord should be a 3-wire grounded extension cord.
- The longer cord should be arranged so that it will not drape over the countertop or tabletop, where it may be pulled on by children or accidentally tripped over.

3 HOW TO USE

The appliance can be used with the relative accessories for cleaning or for ironing.

3.1. STARTING UP

Please note: this machine detects the minerals in the water to determine there is water in the machine, Distilled water lacks minerals and therefore the machine will call for more water and won't heat.

Our recommendation - Please refrain from using well water, water filtered through water softener systems or hard city tap. Normal city tap water, spring water and bottled drinking water are all recommended water types.

Open the water tank cap and fill the tank with a maximum quantity of 1.6 litres of cold tap water (Fig. 16). Then close the cap.

Lift the lid 19 and insert the plug of the steam hose fig. 18. Then ensure that the locking pin of the lid 19 clicks in the plug hole.

Take care that the connections are correctly inserted (Fig. 18). Then simply fit the desired accessory onto the steam gun (Fig. 21).

To remove the accessories press the button on the steam gun (Fig. 22).

Connect the electricity supply cable to the mains socket (Fig. 11).

Switch on the appliance by pressing on the upper part of the switch (Fig. 24); the orange light will come on.

The steam can be used as soon as the steam control light switches on (detail 4 - pag.2) and the pressure gauge shows the pressure value. Press the button on the handle, and then cleaning can begin (Fig. 19). The button must be kept pressed in order to emit steam. To stop the emission of the steam, simply release pressure on the button.

Caution: during the initial heating up phase, the air inside the boiler always produces a pressure that prevents steam output. Therefore, after the first minute of heating up, press the button on the handle a few times.

The steam regulator knob controls steam hose output(C,fig.20).Turn the knob left for higher pressure, wetter steam. Turn the knob right for lower pressure, drier steam. NOTE: Steam output will diminish faster at high pressure settings. Mid to low pressure is best to maintain steam quality.

If the warning light comes on (detail 5 - pag.2) and the buzzer is heard, this means that there is no longer enough water in the tank. Open slowly the tank cap and fill it up with cold tap water.

3.2. USING THE ACCESSORIES

All the accessories can be fitted directly onto the handle or onto the extension tubes.

Caution: check that the surfaces and the fabrics that you wish to steam clean are suitable for this type of treatment before starting to clean them.


Accessory for floors, with or without the cloth, for cleaning all smooth floor surfaces and to freshen up carpets (Fig. 23).

Caution: in the case of delicate surfaces always use the cloth.

Triangular accessory with cloth for cleaning padding, mattresses, kitchen furniture and to freshen up garments.

Glass wiper for cleaning windows, mirrors, shower walls,

Caution: when cleaning cold glass surfaces always keep at a distance of at least 50 cm and work only with the minimum quantity of steam. (The non-observance of this precaution can cause the glass to breaking.)



Nozzle and steam output with or without circular brush and spatula for cleaning points that are difficult to reach such as washbasins, toilet bowls and surfaces in very narrow areas.

Caution: do not use the circular brush and/or spatula on delicate surfaces.

Spatula for cleaning ovens, grills, barbecues, fireplaces and such like.

When cleaning delicate objects (plants) always keep at a distance of 20-40 cm and avoid direct contact with the steam (Fig. 26).

4 MAINTENANCE AND CLEANING

4.1 AFTER STEAM CLEANING

When you have finished cleaning with your steam cleaner, switch off the appliance and leave it to cool completely before putting it away.


4.2 MAINTENANCE AND CLEANING


The water filter must be periodically cleaned, remove it from the opening where the water is poured in. When carrying out maintenance operations, the appliance must not be plugged into the electricity supply. Routine checks carried out by an authorised Servicing Centre will increase the life and the reliability of your appliance. Keep the original carton in which your appliance was packed to protect it during transport.
